Profile

Mr. Zhang has also participated in the research and formulation of the 12th, 13th and 14th Five-Year Plans of the CNIPA, and is familiar with the work of administrative affairs of state organs with a high level of legal policy.

Prior to joining the CNIPA, Mr. Zhang has handled hundreds of legal matters in a wide range of fields, including civil, criminal, administrative and arbitration.
